Dear Redistricting Commission Members,
I have lived, worked, and paid taxes in the City of Lynchburg for nearly 20 years. As you draw lines, I urge you to keep Lynchburg WHOLE as ONE COMMUNITY OF INTEREST, within one HOD district and one state Senate district. Lynchburg's social, cultural, and economic needs as a small urban city and a regional hub of activity are quite different from those of our surrounding, more rural counties (to whom we have arbitrarily been attached to since the 2011 drawing of maps). From the perspective of taxes, infrastructure needs, economic development, the public school system, environmental & planning pressures, gun rights, and public safety, the City of Lynchburg's needs and interests are best advocated for by a single House Delegate and a single state Senator for whom Lynchburg voters are the bulk of their constituents. Currently, Lynchburg's four-way cracking into four arbitrary districts (2 Senate districts, and 2 HOD districts) is utterly confusing to voters, makes elections more expensive to administer, and worst of all, breaks up Lynchburg's clout as a single community and does not serve its interests. Please restore Lynchburg to the pre-2011 lines as the single community of interest that we naturally are, within a single HOD and a single Senate district.
