COMMENTS:

I want to thank you for the work you have done so far. I have tried to watch each livestream and review maps and comments submitted by the public. Your work hasn't gone unnoticed, and I appreciate your dedication to this process.

I fear that citizens who voted for the creation of this commission trusted that this process would be handled in a fair and balanced manner. So far, I have seen lots of party line votes. I voted no for the creation of this commission because I feared that having members of the General Assembly involved in map making would lead to drawn out battles that would eventually be sent to the Virginia Supreme Court.

I am writing to express concern over input from the public in the region of Pittsylvania and Henry counties and the cities of Martinsville and Danville. As I have mentioned previously, this region has seen low levels of engagement. After watching the virtual public hearings for Southwest and Southside I have noticed a trend. There is a disproportionate amount of input from current or former elected officials. These people can flood these spaces and dilute the input of everyday citizens, thus convincing commission members that certain proposed maps are fair or generally agreed upon. I am disappointed to see that neither set of consultants have attempted to draw a district that contains both Martinsville and Danville, despite public comment and public submitted maps that support this idea. A district with both cities would be highly competitive, which is rare for this area of the state, as our current districts are drawn in such a way that they are politically uncompetitive. Today, 3 current elected officials and 1 former elected official commented on the proposed maps for Danville, Martinsville, and Henry and Pittsylvania counties. The consensus was that Danville and Martinsville should be in separate districts.

I ask that members of the commission take into consideration that these views may not represent the views of citizens of Danville and Martinsville. As you continue to draw statewide districts and as you prepare to draw

I am writing to share my opinion about the redistricting process that is underway in the Commonwealth of Virginia. It is my understanding that there is a possibility of combining Russell County with Washington County and the City of Bristol. Even though Russell County adjoins Washington County, Russell County does not share many natural relationships with Washington County and especially not with Bristol. Whether the consideration is for Community College opportunities, Health District guidance, economic relationships related to transportation, or regional educational partnerships, Russell County is a much more natural fit with Tazewell County, Buchanan County, etc. The current recommendation honors this ideal by aligning District 100 in a way that keeps LENOWISCO and Mountain Empire Community College counties together.

Some examples of the benefits of excluding Russell County from a District with Bristol and Washington County include:

- Throughout the pandemic the Mount Rogers Health District has provided guidance to their school divisions that has been different than the guidance from other Health District guidance based on community metrics and practices.
- Virginia Highlands Community College serves as an important partner with our school divisions and offers workforce development opportunities based on our communities' needs.
- The economy on the 1-81 corridor is very different than the economy that is accessed by Highway 19.
- School divisions on the 1-81 corridor have regional partnerships for Special Education, transportation, and mental health related services because of the natural collaborations that are afforded due to proximity, accessibility, and even similar weather patterns.

Objection to draft redrawing of Senate District 21

The proposed redrawing of Senate District 21 is fundamentally flawed. Severing the Town of Blacksburg from Roanoke City and placing them separate districts may appear sensible because they are in two separate valleys, but the logic is faulty. Geography is not necessarily a good indicator of community.

The two municipalities connected by I-81 are one community (in the sense of central city and suburb). People commute daily in both directions between home and work. Many of them are healthcare workers employed by Lewis Gale and Carilion, which have divided their facilities in both locations. Higher education is linked through the regional association and direct relationships among faculty and students. Folks in Blacksburg and Christiansburg rely on the city for shopping, the arts, entertainment and good restaurants. Soon we will be linked again by rail (Amtrak). The NRV's small Black community's best chance for representation lies in remaining in the same election district as the much larger Roanoke African-American community.

Dear Commissioners – Please accept these comments in the spirit of making sure that the four counties of the Cumberland Plateau Planning District Commission (Buchanan, Dickenson, Russell and Tazewell) are recognized as communities of interest in that they share many things in common and have worked together for decades in many different ways to address their many challenges. The same could be said for our neighboring PDC, Lenowisco, which is home to 3 coal-producing counties. Of the 19 counties in Southwest Virginia, the coalfield counties have a history of working together on many different initiatives. A good example is the recent creation of the Cumberland Industrial Facilities Authority (CIFA) by Buchanan, Russell and Tazewell Counties (Dickenson County is considering joining as well). The Authority members have entered a Revenue Sharing Agreement in support of perhaps the largest single economic project in the Cumberland Plateau - Pure Salmon. This aquaculture project, known locally as Project Jonah, will create 200 new good paying jobs with a capital investment of \$228 million. The three member counties each committed \$1 million to the project and will share in the revenues. This is just one example of many regional efforts that illustrate the cohesiveness of the 4 Cumberland Plateau counties. Others include: (1) Cumberland Plateau Regional Industrial Park; (2) Cumberland Plateau Regional Opportunity Program (CProp); (3) Cumberland Plateau/Lenowisco Revolving Loan Fund; (4) Cumberland Plateau Regional Broadband Project;

(5) Cumberland Plateau Regional Outdoor Recreation Initiative; and (6) Cumberland Plateau Regional Water and Sewer Roundtable.
